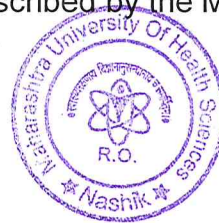

- 8) The college shall not admit the students for the Academic Year **2025-26** after the cut-off date prescribed by the CCIM /(NCISM), New Delhi.
